The HR Director and Executive Department Manager Fidan Gousseynoff informed that the Minutes of February  $21^{\rm st}$ , 2023 will be provided at the regular meeting on March  $21^{\rm st}$ . She presented brief information about Item E-1 and explained that in accordance with DHCD requirements, the SHA needs its Board approval to include Executive Director Denise Jordan's salary to the budget for FY23. The new salary calculation worksheet was also presented and it was noted that current salary is within the limits established by DHCD. The Board was reminded that the contract with Ms. Jordan and the salary was approved by the Board on December  $21^{\rm st}$ , 2021 and DHCD approved the contract on 4/11/2022, however, due to a clerical error, the new salary was not included to the budget that was approved on 5/17/2022.

Upon a motion made by Commissioner Thomas, seconded by Commissioner Warren and following a roll call, it was unanimously

VOTED: to adopt Resolution #9772 to approve including to the SHA budget the Executive Director's salary as follows: annual salary in the amount of \$175,000 for FY2023; annual salary in the amount of \$175,000 for FY2024; annual salary in the amount of \$180,000 for FY2025.

The Board reviewed item E2 presented by Ms. Gousseynoff who explained that the budget certificates for state programs that were approved by the Board of Commissioners at the February meeting need to be re-submitted because the ED salary listed in those certificates was old. It was noted that after the approval, the updated certificates had to be signed by all Board members to be submitted to DHCD. Upon a motion made by Commissioner Warren, seconded by Commissioner Thomas and following a roll call, it was unanimously

VOTED: to adopt Resolution #9773 to approve the re-submission of the state budget certification for fiscal year 2023 for the following programs: MRVP, 200-A, 705-A, 689-C, and 400-1.

There being no further business to come before the members of the Springfield Housing Authority Board, upon a motion made by Commissioner Thomas, seconded by Commissioner Warren, and following a board roll call, it was unanimously

VOTED: to adjourn the Open Session of the Special Meeting of the Springfield Housing Authority at 1:08 PM.
